1. Prior to securing a slot for services, all fees are payable in advance online at fkchestnutdrivingacademy.com
NO EXCEPTIONS.
2. All educational materials issued are the property of the school and they must be returned in good condition at the completion of the course.
3. **If you cannot keep your scheduled appointment for driving, you must notify the instructor at least (24) hours in advance. If you must cancel for any reason on the day of your scheduled appointment, your session for that day will be considered as completed and you will not be refunded for that time.**
4. **All early withdrawals in the classroom, subject to a \$50 per session early withdrawal fee.**
5. No certificate of completion will be issued until all fees have been paid in full.
6. FK Chestnut Driving academy DOES NOT ACCEPT CHECKS. *We only accept cash for pick up fees for clients outside of Caldwell and Catawba counties.* The cash pick up fee is due on the day of your driving lesson at the scheduled start time.
7. The school will complete the course within a reasonable length of time; however, it cannot be held responsible for delays caused by unsafe driving conditions due to bad weather, mechanical problems, or any other reasons over which it has no control. The school will give as much notice as possible. If any delay becomes necessary.
8. The fees contained herein cannot be guaranteed longer than (90) days from the beginning date of the course.
9. The school cannot guarantee that the student will successfully pass the examinations given by the Division of Motor Vehicles upon completion of the course. The school will undertake to exert its best efforts in teaching the student to meet the requirements of the examinations.
10. If the student is less than eighteen (18) years of age, a parent or guardian must sign this contract.
11. The client/student fully releases the school, it's agents and employees, from any liability whatsoever, and from any and all claims or causes of action resulting or arising from any damage or injuries suffered by the student during this course or any extension thereof, to the extent that such claims shall not be covered by the school's insurance coverage.
